MEMORANDUM TO THE CONFERENCE:

Re: No. 665 Misc. - Relford v. Commandant

You may recall that the special Wednesday Conference voted as follows on the above petition for certiorari:

GRANT	DENY
TM	WJB
BRW	JMH
PS	WOD
HLB	CJ

The Wednesday Conference actions went on an Order List Friday for announcement.

Late today Justice Douglas wrote me requesting announcement be deferred and the case be placed on the March 6 Conference List. He was not aware that the Wednesday actions were placed on a Friday Order List. Meanwhile, Justice Douglas was advised that the order had been announced.

Shortly after Justice Douglas' note Justice Black advised he was changing his vote to deny cert, thus leaving 3 to grant and 5 to deny.

After exploring the whole matter, I conclude that the Friday order should not be revoked now but should await the action on March 6 to be sure no other Justice is to change his vote. Were we to revoke the grant of cert and another Justice change his vote to a grant, we would then be required to retrace our steps once again.

Unless someone sees an urgent need for an immediate revocation, an orderly change following a regular Conference will reflect our final action without risk of a double reversal.
