



MR. JUSTICE STEWART delivered the opinion of the
Court.

Under Georgia law a candidate for elective public office who does not enter and win a political party's primary election can have his name printed on the ballot at the general election only if he has filed a nominating petition signed by at least 5% of the number of registered voters at the last general election for the office in question.¹ Georgia law also provides that a candidate for elective public office must pay a filing fee equal to five percent of the annual salary of the office he is seeking.² This litigation arose when the applicants, who were prospective candidates and registered voters, filed a class action in the United States District Court for the Northern District of Georgia, attacking the constitutionality of


