

MR. JUSTICE WHITE, dissenting.

Respondent members of the Calhoun County, Miss., school board adopted a policy in Nov., 1972, providing:

"Prior to the employment of a new teacher, or the reemployment of an existing teacher, the children of any such teacher, if living in Calhoun County, Mississippi, will be required to attend the public schools of Calhoun County or said teacher will not be employed or reemployed." 511 F. 2d 744, 746 (CA5 1975).

At the time the policy was adopted, petitioners were teachers residing in Calhoun County and teaching in its public school system. Petitioners represented collectively over 20 years of teaching experience (eight, eight, and four and one-half years respectively).* Each of the petitioners sent their children to Calhoun Academy, an all-white secular private school. After petitioners announced that they would not comply with respondents' policy, respondents refused to renew their one-year teaching contracts for the following academic year.

Petitioners filed suit under 42 U. S. C. § 1983 seeking reinstatement, backpay, and monetary damages. They claimed that imposition of respondents' policy violated
