MR. CHIEF JUSTICE BURGER delivered the opinion of the Court.

I

The United States began this original action against the State of California under Article III, Section 2, of the Constitution in 1945 to determine whether the right to exploit natural resources under the submerged lands off the California coast belongs to the United States or to California.

In 1947, this Court decreed that the United States owned all submerged lands extending seaward of the ordinary low water mark on the California coast. United States v. California, 332 U.S. 804, 805 (1947). See also United States v. California, 332 U.S. 19 (1947). When Congress enacted the Submerged Lands Act of 1953, 67 Stat. 29, 43 U.S.C. §§ 1301, et seq., the United States, in effect, quitclaimed to California whatever interest the federal government may have had in, and to, all lands and natural resources lying within three geographical miles seaward of the California coast line. § 3(b)(1), 43 U.S.C. § 1311(b)(1). Congress subsequently enacted the Outer

S. C. § 1311 (b)(1). Congress subsequently enacted the Outer Continental Shelf Lands Act of 1953, 67 Stat. 462 (1953), 43 U. S. C. § 1331 *et seq.*, which declared that the United States owned all submerged lands seaward of those granted to California by the Submerged Lands Act. *Id.*, § 1332, 1333.


